A Bylaw to amend the sewer user rates as established by Bylaw No. 410, 2001

WHEREAS it is deemed necessary to amend the sewer user rates as set out in Bylaw No. 410, 2001;

NOW THEREFORE the Council of the Village of Hazelton in open meeting assembled, enacts as follows:

1. Annual rates for use of the sanitary sewer are established as set out in Schedule "A" of this bylaw.
2. Schedule "A" of Bylaw No. 410, 2001 is repealed in its entirety.
3. This Bylaw may be cited for all purposes as "Sewer Connection Regulation and Rates Amendment Bylaw No. 464, 2014".

Residential-per family unit (includes mobile homes and each unit of apartment, suites or attached living quarters)	\$18.00
Commercial, Professional Business Office – per tenant	\$18.00
Restaurant, Pub, Beer Parlour	\$35.00
Hairdressers, Day Spa	\$35.00
School or College	
-Per first room	\$35.00
-per additional room	\$18.00

-per first bed	\$28.00
-per additional bed	\$14.00
Hotel, Motel or Dormitory	
-per bed	\$6.00
Laundromat	
-per washer	\$6.00
Theatre, Art Gallery	\$18.00

**CONNECTIONS/DISCONNECTIONS**

New connections shall be installed at actual cost of labour, materials, equipment, supervision and Administration (20%). The owner shall also pay all costs for repair to road surfaces, curb and gutter, sidewalks and boulevards disturbed by the installation.

Service Connection/Disconnection Inspection Fee	\$100
Disconnection Charge (cap off service pipe)	\$500

Rates will be billed 3 times per year. A 10% discount will apply to each trimester billing if the bill is paid by the due date established for that period.
