A Bylaw to establish fees and charges for certain services

- 1. Administrative Fees and Charges will be in accordance with Schedule "A" of this bylaw.
- 2. Land Use Development Fees will be in accordance with Schedule "B" of this bylaw.
- 3. This Bylaw may be cited for all purposes as the "Fees & Charges Bylaw No 468, 2014".

### **Development Procedure Fees:**

Official Community Plan amendment application \$500.00 + advertising Zoning Bylaw amendment application \$500.00 + advertising Official Community Plan and Zoning \$750.00 + advertising Development Variance Permit \$500.00 + advertising

Subdivision application fee

\$100.00

If approved, \$250.00 for first parcel and \$100.00 for each subsequent parcel created.

<sup>\*</sup>If an application for a zoning and/or Official Community Plan amendment is outright refused by Council, the applicant is entitled to a 75% refund of the fee paid.
